**Saturday, 11 September 2010**

- Set-up begins at 9:00 a.m. and vendors must be set-up by 11:30 a.m. Festival events are from 11:00 a.m. to 11:00 p.m.

**VENDOR FEES**

All spacing is based on a 10' by 10' area and this includes all trailers and towing attachments. If the trailers and towing attachments will not fit into the 10' x 10' space then the vendor must rent more than one space.
